LPPD Application and Information Request Form

General Descriptions

- you may request them to be corrected, updated in case of incomplete or incorrect processing, or to be deleted in the way that include the notifications to third parties to whom the transfer has been made if the reasons for their processing have disappeared.

- By notary public or registered mail,
